

Subject: Decision on Appeal against non- accreditation to the UG Engineering programs offered by Rungta College of Engineering and Technology, Rungta Educational Campus, Kohka Road, Kurud-490024, Chhattisgarh.

Sir,

This has reference to Appeal dated 02-05-2023 filed by Rungta College of Engineering and Technology, Rungta Educational Campus, Kohka Road, Kurud-490024, Chhattisgarh, against NBA's decision of not granting accreditation to its UG-Computer Science & Engineering and Information Technology Programs of the Institution as communicated vide NBA's letter of even number dated 06-04-2023.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 14/12/2023. On the recommendation of the Appellate Committee, revisit to the Institution was held during 23rd to 25th February, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. On their recommendation and the recommendation made by the Appellate Committee in its meeting held on 26/03/2024, the competent authority in NBA has approved the following accreditation status to the program as given in the table below:

- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The program has been granted accreditation for 3 years Rungta College of Engineering and Technology, Rungta Educational Campus, Kohka Road, Kurud-490024, Chhattisgarh should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
- 5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Rungta College of Engineering and Technology, Rungta Educational Campus, Kohka Road, Kurud-490024, Chhattisgarh as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

 desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the
 website and information bulletin of the Institute.
- 7. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
